## DME: Scalp Hair Prosthesis (Wigs)

The purpose of this policy is to provide clarity and specificity for coverage for DME: Scalp Hair Prosthesis (Wigs). Coverage is available for wigs for alopecia areata, as required by MN Statute 62A.28, in addition to the conditions of alopecia totalis, alopecia universalis, and for hair loss due to chemotherapy or radiation of the head and neck. Wigs may also be referred to as scalp hair prosthesis or cranial scalp prosthesis.

## **Definitions or summary**

**Required coverage** under *Mn Statute* 62A.28 COVERAGE FOR SCALP HAIR PROSTHESES.

*Every policy, plan, certificate, or contract referred to in subdivision 1 issued or renewed after August 1, 1987, must provide coverage for scalp hair prostheses worn for hair loss suffered as a result of alopecia areata.* 

The coverage required by this section is subject to the co-payment, coinsurance, deductible, and other enrollee cost-sharing requirements that apply to similar types of items under the policy, plan, certificate, or contract and may be limited to one prosthesis per benefit year.

**Alopecia Areata-** a condition that causes round patches of hair loss that can lead to total hair loss. It is thought to be an autoimmune condition that occurs when the immune system mistakenly attacks and destroys healthy hair follicles.

**Alopecia totalis** — Total loss of the hair on the scalp.

**Alopecia universalis** – Complete loss of hair on the scalp, face, and body.

The following type of alopecia **does not meet** the language of the mandate for coverage.

 Androgenic alopecia - is common for women and men. It's also known as maleor female- pattern hair loss.

#### **Coverage policy**

#### COVERED

- Hair prosthesis (i.e., wig) for hair loss resulting from:
  - alopecia areata
    - No dollar or hair length coverage limits
  - alopecia totalis, alopecia universalis, hair loss due to chemo and/or radiation of the head or neck
    - \$600 reimbursement limit, and 22" hair length limit
  - one hair prosthesis per member per calendar year
  - A prescription from health care provider indicating alopecia areata, alopecia totalis, alopecia universalis, or hair loss is due to chemotherapy and/or radiation to the head or neck.
  - Wigs can be obtained at a salon, retail store or online.
  - Member may submit receipt for reimbursement under this benefit using the UCare Health Care Expense Claim Form.
  - One prosthesis (wig) per person per calendar year.

#### **NOT COVERED**

Wigs for conditions other than in the covered section listed above include, but are not limited to:

- Androgenic alopecia
- Dermatological conditions
- Fungal infections
- Injury resulting in hair loss
- Medication
- Nutritional deficiencies
- Pregnancy
