MSC+ Skilled Nursing Facility	Notification within 24 hours of admission. Medicare A Days: UCare is not approval authority for Medicare coverage for MSC+ members.	Fax DHS 4461 Nursing Facility Communication form to UCare. Indicate if days are Medicare certified. All days counted up to 180 days are health plan liability. Include Minnesota RUG on Nursing Facility Communication form.
MSHO Skilled Nursing Facility (For members how have Medicare coverage through UCare).	Notification within 24 hours of admission. Concurrent review required for additional skilled days.	Fax DHS 4461 Nursing Facility Communication form to UCare. Include all MD orders for admission to skilled care and treatment plan, therapy evaluations etc. Discharge summary required to be sent to UCare upon discharge.

Durable Medical Equipment (DME) (For DME not part of the NH Facility per diem).	Durable Medical Equipment - Purchase & Rental: Some DME requires PA.	Use UCare provider network search. Podiatry	Not required.	Use UCare provider network search.

Therapies PT, OT, ST	PA not required for skilled nursing stay. PA not required for NF therapies. Non contracted PT/OT/ST requires PA.	Use UCare provider network search. MSC+ with Medicare: Verify Medicare coverage in MN-ITS. If Medicare is primary insurance, follow Medicare guidelines.
Transportation (medical)	Not required.	Health Ride 612-676-6830 or 800-864-2157 or 911 for emergencies.
