# UCare to Expand MinnesotaCare and Medical Assistance Services In Minnesota

On May 1, 2017, UCare will begin serving an estimated 165,000 additional members of Prepaid Medical Assistance Program (PMAP) and MinnesotaCare in Minnesota. DHS invited UCare to help fill the coverage gap created by the withdrawal from this service by another Minnesota health plan, effective April 30, 2017. Under amended contracts with the Minnesota Department of Human Services (DHS), UCare will offer MinnesotaCare in 55 counties and PMAP service in 38 counties.

UCare currently serves approximately 12,000 PMAP and MinnesotaCare members in Olmsted County.
