What is the overall deductible?	In-network: \$3,000/Individual; \$6,000/Family. Non-network: \$15,000/Individual; \$30,000/Family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the plan, each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. <u>Preventive services</u> and office visits. <u>Formulary</u> drugs except non-preferred brand and specialty. Limitations apply. <u>Copayments</u> don't apply to <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount.
